- A grade of "C-" or better earns a "P" grade; a grade of D+ or lower earns a "NP" grade.
- The P/NP option is permitted for electives only and may NOT be chosen for any course used to satisfy a requirement. This includes Foundations, Distributions, Non-Western Culture, Explorations, Writing, Language Studies or major/minor requirements.
- Students who are repeating a course taken for a regular grade may not choose this option.
- The P/NP option is open to students only after one semester has been completed at Franklin & Marshall.
- Students may elect to take a maximum of eight courses on a P/NP basis.
- Students may not take more than one P/NP course per semester unless they are enrolled in five full-credit courses, in which case they may take two.
- Internship credits are considered one P/NP.
- If your adviser is also the instructor of the course, the Department chair or a member of the Office of College House Administration staff should sign the form.
